The other terms and conditions are as under :-

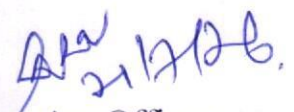
- 1) The Driver should attend the office of Nabadwip Municipality on all working days from 8.00 A. M. and will be released at 8.00 P. M.
- 2) The Driver shall attend on Sundays and holidays on demand and when required.
- 3) The Driver may be required to remain on duty beyond normal duty hours and may also be required to be placed earlier than 8.00 A. M. occasionally.
- 4) Logbook shall be maintained by the driver of the car and every entry these shall be authenticated by the Executive Officer, Nabadwip Municipality and by such officials using the vehicle and maintain the HSD receiving and consuming statements.
- 5) The Vehicle shall get the same regularly examined by the efficient and eligible skilled motor mechanic of his choice. In the event of breakdown and or during the period of routine maintenance and repairing charge of which shall have to be borne by the driver upto Limit Rs. 2000/- only.
- 6) No compensation shall be allowed to the driver on any account whatsoever.
